Waiver of Liability and Indemnification

kin, successors and assigns, User agrees to voluntarily:

- a. **waive, release, and discharge:** Town of Land O' Lakes, its departments, members, employees, agents, sponsors,
volunteers, insurers, organizers, and others acting on their behalf from any and all negligence and liability for my death,
disability, personal injury, property damages, property theft or claims of any nature which may hereafter accrue to me,
and my estate as a direct or indirect result of my Use of the requested Town facility(s); and
- b. **defend, indemnify, and hold harmless:** Town of Land O' Lakes, its departments, members, employees, agents,
sponsors, volunteers, insurers, organizers, and others acting on their behalf from any and all claims of any nature,
including all costs, expenses, and attorney's fees, which may in any manner result from or arise out of this agreement.

This contract shall not be considered final or binding unless or until confirmed by the TOWN CLERK.
